## 5. CAPTAIN'S REPORT

Rosemary Barford, Captain, report as follows:

Good morning, ladies, or to be politically correct should I just say good morning, everybody!

Welcome again to this year's SLCSGA AGM.I think that enough has already been said about the last two years, all I shall add is to say that things have been tough for a lot of people, and if all we have to worry about is some cancelled golf – well, that's not so bad.

We obviously pay for the food but are not charged a full Green Fee., though we do make a donation to the host club. Sadly, a couple of months ago, we learnt of the death of Lyn Turner, a member of Mannings Heath, she was Captain of our Society in 2009 – 2010. Our thoughts are with her family.

I think that's probably enough from me, I just have to present this gift to Lesley Talbot whose time on the Committee has come to an end. We can proceed to the next item on the agenda, which I believe is the Treasurer's Report.

## 6. TREASURER'S REPORT

Nikki Terry, Treasurer reported as follows:

I have pleasure in presenting the Income and Expenditure Account to 14<sup>th</sup> October 2021.

The accounts look a bit more 'normal' this year with the exception of the cancellation of our Spring Meeting and two of our early matches due to Coronavirus.

The Accounts show a surplus this year and this is mainly due to our event and match venues keeping the cost of catering at a sensible rate. Also, we had £625 of prize vouchers in hand from the cancelled Spring Meeting in 2020, which we have now used for prizes at Presidents Day.

Although we have increased our subscriptions by £1 this year, we are keeping the cost of events the same at £37.50. We hope you will continue your support of our events in 2022 and there are no more disruptions!

I am stepping down as Treasurer today after serving 6 years on the Committee first as President and then as Treasurer. I have thoroughly enjoyed being part of this committee and will miss our friendly but decisive committee meetings, which often include lunch.

I hope the Accounts meet with your approval.

#### 7. INCOMING OFFICERS

One possible solution is to 'open up' the membership to other 'senior/important' positions within the ladies committee of clubs, as they are clearly taking on much more responsibility without taking on the role as Captain. Perhaps you might like to discuss this within your own club – we would love to receive your views and have your input, after all, it ultimately affects us all.

So, on that note, I look forward to seeing you at the matches and events next year, just let's hope we have a glorious summer to go with it!
